Council discussed the justification for purchasing an excavator. Administration explained that the equipment is required for the landfill in order to compact the solid waste in the landfill cells. An excavator may not necessarily be the right choice, however as the Town is no longer permitted to burn, it needs to be determined how the garbage will be handled and a piece of equipment whether a compactor or a Caterpillar (Cat) will be required. Mayor Durocher expressed his concerns that this would directly impact local contractors that provide this type of equipment as part of their business. Councilor Slager stated that contractors may not always be available on short notice when the equipment is required. Although the cost is excessive, it was suggested that if the Town proceed with the purchase, to apply for CDF funding to help offset the cost.
