DELEGATION

CONSTABLE SUAVE 2016 HOCKEY CAMP

Constable JM Suave provided Council with an update on the 2015 Hockey Camp that was held in Watson Lake. The hockey camp was very successful, and received positive feedback from the community. There has been an enormous amount of exposure for Watson Lake through social media with approximately ½ million viewers via twitter and facebook. Funding for the event was secured from various sources including the Community Development fund, personal donations, corporate/business sponsorship and in-kind donations. The organizing committee is willing to repeat the event in 2016, however they request more cooperation from the Town of Watson Lake. Better communication and assistance is required to ensure the success of this event and to promote economic opportunities for the community. Council agreed to discuss this more at the next regular Council meeting.

RCMP Sergeant Cam Lockwood welcomed the newly elected Council. Sergeant Lockwood would like to have an open door policy and is willing to meet with Council to discuss detachment priorities. Sergeant Lockwood provided Council with the policing report and updated Council on various matters which the RCMP have dealt with. A monthly report will be provided to Council.

Srgt. Lockwood addressed the following concerns:

Skateboard Park – The RCMP are having to respond to complaints regarding alcohol & drug abuse that is occurring there. This is a huge liability for the Town of Watson Lake and it is recommended that the skateboard park be eliminated or relocated.

Recplex extended hours – Due to the large number of youth that are out on the streets, it would be beneficial to extend the hours at the Recplex including weekends to provide a safe place for youth. Drop-in programs would encourage youth to stay off the streets.

Street lights along Robert Campbell highway – It is suggested to have adequate street lights along the Robert Campbell Highway to 2 & 2 ½ mile.

Sergeant Lockwood discussed the enforcement of Town Bylaws and enquired whether a Bylaw Enforcement Officer is going to be hired as the RCMP do not enforce Town Bylaws. Council and agreed to discuss this further and thanked Sergeant Lockwood for attending the meeting.
