WL SANI DUMP

Council addressed the sani-dump located at Wye Lake Park and suggestions from Environmental Health as to how the sani-dump site could be modified for public access and not present a risk to the users. Council expressed concerns that there are many events held in Wye Lake Park and this may not be the best location for the sani-dump. Council discussed a proposal from a local contractor to facilitate establishment of a sani-dump on his property for use by tourists and locals. Council considered both options and suggested the sani-dump be recommissioned to be open to the public on days where no events are taking place in the Park. Councilor Lund agreed more information is required before making a decision.

Council discussed By-law 15-05, being a bylaw to govern the use of parks & public open space within the Town of Watson Lake, and problems associated with camping permits issued for the Watson Lake Airport Campground site.

YTG – VISITOR INFO CENTRE MEETING

Council agreed to meet with AYC President Diana Rogerson on July 18<sup>th</sup> at 9:00 am.

**DELEGATION** 

RCMP Sergeant Lockwood discussed the proposal for a Skateboard Park/Youth Centre that was submitted by the Town of Watson Lake Recreation Programmer to revamp the existing skateboard Park and incorporate a youth centre. Sergeant Lockwood expressed concerns with the location of the skateboard park and the low visibility, and the potential of public health and safety risks. Sergeant Lockwood suggested that the skateboard be relocated to a site that is more visible with less liability. He also suggested that the Recreation Centre be open more hours to accommodate the youth.

Sergeant Lockwood addressed a letter from the WL Library Board expressing concerns with the intoxication that occurs in the library and the problems they have encountered as a result. The RCMP have taken action to address the situation of alcohol, however this is a reoccurring problem.

Sergeant Lockwood suggested the Town remove the brush from the multi-use trail system as the trails have become overgrown and are no longer accessible to the public. Also the willows and brush need to be cleaned back at some intersections along Frank & Adela Trail due to limited visibility.

Council reviewed the May RCMP Policing report and thanked Sergeant Lockwood for attending the meeting.

ADMINISTRATIVE ENQUIRIES

Councilor Bauer questioned whether had been any policies or procedures put in place for those contractors wishing to access the sewage lagoon. Administration advised this is still underway.
