LFN/TOWN OF WATSON LAKE CO-OPERATION ACCORD

Council reviewed a 2004 co-operation accord between the Liard First Nation Government and the Town of Watson Lake. The purpose of the Accord is to provide a framework for the parties to jointly identify, resolve and work on matters of mutual interest and priority in a timely manner, and to enhance the relationship between the LFN and the Town. Council agreed to move forward on this initiative and suggested a meeting be arranged with the newly elected Council after the LFN election.

LAND DEVELOPMENT PROTOCOL

Council addressed the land development protocol between the Government of Yukon and the Town of Watson Lake. The purpose is to acknowledge the intent of the parties to work together in the identification of development lands and in the provision of land development services within the Town of Watson Lake.
