CAO REPORT

Administration discussed a meeting that was held with a representative from Greyhound to address the status of Greyhound Services to Watson Lake. May 31st is the last day that Greyhound will offer passenger service, however freight delivery will continue. Greyhound has expressed an interest in maintaining their office at the Recreation Centre with reduced hours.

Administration addressed the Town advertising and budget. Various advertisements featuring Watson Lake is outdated and costly. It was suggested that the Town work with the Chamber of Commerce to discuss an advertising plan that explores options to provide updated advertising to promote Watson Lake.

The Community Garden proposal was discussed. In order to go forward with a CDF funding application, a letter is required from the Town supporting the project. It does not require that a specific location be identified. Council expressed concerns that the proposed location at the Northern lights Centre is not a suitable location and that other options need to explored.
